

## WHITETAIL WEDNESDAYS SWEEPSTAKES OFFICIAL RULES

### NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

Purchase will not increase your odds of winning.

**1. SWEEPSTAKES PERIOD:** The Whitetail Wednesdays Sweepstakes (the “Sweepstakes”) begins at 12:01 a.m. Central Time, October 7, 2015 and ends at 11:59 p.m. CT, October 28, 2015 (the “Sweepstakes Period”). Sponsor’s computer is the office time-keeping device for the Sweepstakes. The Sweepstakes consists of four (4) consecutive Wednesday entry periods (each an “Entry Period” and collectively the “Entry Periods”) as set forth below and a Grand Prize drawing.

**2. ELIGIBILITY:** The Sweepstakes is only open to legal residents of the United States of America and the District of Columbia who are of at least 18 years or older (19 in AL and NE). Employees, contractors, and agents of The Sportsman’s Guide, Inc. (“Sponsor”) and its parent, affiliate and subsidiary companies and brands (collectively the “Sponsor Entities”), and the immediate family members (e.g. spouse, parent, child or sibling and their respective spouses, regardless of where they reside) or household members, whether or not related, of such individuals are not eligible to enter or win.
