

## TROPHY TURKEY HUNT 2016 OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN.  
Purchase will not increase your odds of winning.**

THIS SWEEPSTAKES IS ONLY INTENDED FOR ELIGIBLE PARTICIPANTS AND WILL BE GOVERNED BY APPLICABLE U.S. LAW. DO NOT ENTER IF YOU DO NOT AGREE WITH THESE OFFICIAL RULES OR ARE NOT ELIGIBLE TO PARTICIPATE. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

**1. SWEEPSTAKES PERIOD:** The Trophy Turkey Hunt 2016 (the "Sweepstakes") begins at 12:01 a.m. Central Time, February 29, 2016 and ends at 11:59 p.m. CT, March 17, 2016 (the "Sweepstakes Period"). Sponsor's computer is the office time-keeping device for the Sweepstakes.

**2. ELIGIBILITY:** Sweepstakes is open to legal residents of the fifty (50) United States or District of Columbia who as of the date of his/her submission is 18 years of age or older (19 in AL and NE). Individuals who are employees, contractors, or agents of The Sportsman's Guide, Inc. ("Sponsor"), and their respective parents, subsidiaries, affiliates and advertising and promotion agencies, and the immediate family members (e.g. spouses, domestic partners, parents, children and siblings and their respective spouses or domestic partners, regardless of where they live) or members of the same households (whether related or not) of such individuals are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state, and local laws.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a Prize is contingent upon not only proof of eligibility but upon fulfilling all requirements of the Official Rules.

**3. HOW TO ENTER:** The Sweepstakes is an online promotion. During the Sweepstakes Period you can enter at <http://www.sportsmansguide.com/giveaway/giveawayregistration?id=7199>. You must complete and submit the entry form as instructed. Entrants will be required to: (A) complete the online entry form and provide certain information, including first and last name, email address, phone number, and complete mailing address; and (B) confirm eligibility and agreement with these Official Rules. After all requirements have been met, entrant will receive one (1) entry for the Sweepstakes ("Entry") into the Prize drawing.

**Limit:** There is a limit of one (1) Entry per person during the Sweepstakes Period. Any attempt by any entrant to obtain more than the permitted number of entries by using multiple/different email addresses, identities or registration information, or by any other methods, will automatically void all of that entrant's Entries and the entrant may be disqualified from all participation. Use of any automated system to enter is prohibited and will disqualify the entrant on all of their attempted or actual Entries. Any decision to void an Entry or disqualify an entrant is made at Sponsor's sole discretion.

**Consent to Receive Email:** During the entry process, entrants have the option to sign-up for Sponsor's email marketing program. Consenting to receive email marketing is optional and does not increase an entrant's odds of winning. Entrants may opt-out of the receipt of such emails at any time following the directions in Sponsor's Privacy Policy or in any email marketing messages received from Sponsor.

**4. RANDOM DRAWING:** Sponsor will randomly select one (1) potential prize winner on or about March 21, 2016 for the "Prize" as set forth in Section 5 below from among all eligible Entries. The drawing will take place at Sponsor's offices in South St. Paul, Minnesota. Odds of winning depend upon the number of eligible Entries received.

**5. PRIZE / APPROXIMATE RETAIL VALUE ("ARV"):** One (1) 2-Day Turkey Hunt (ARV USD \$4,000) will be awarded (the "Prize").

If the verified Prize winner resides within a 150 mile radius of the Tulsa, OK airport, Sponsor reserves the right to provide ground transportation in lieu of air transportation and no compensation or substitution will be provided for difference in the Prize value. The stay must be completed on the dates scheduled by Sponsor and all travel arrangements must be through Sportsman's Guide and its designated travel agency no later than April 4, 2016. or the Prize will be forfeited in its entirety. Winner is responsible for following all airline requirements for transporting a firearm or any other equipment winner elects to bring for the hunt. Sponsor will not be responsible for any lost, mutilated, or stolen tickets, travel vouchers or certificates. Prize is made available in part by GSM LLC and 180 Outdoors LLC (collectively, the "Donor Entities").

Prizes are not transferable or redeemable for cash. Prize substitution will not be allowed, except at the sole discretion of Sponsor. Prizes are awarded "as is" with no warranty or guarantee, either express or implied by Sponsor or Donor Entities. Sponsor reserves the right to substitute a Prize (or portion thereof) of comparable or greater value, at its sole discretion. Actual Prize value may vary based on costs in travel costs other variable costs associated with the hunt or because of retail sale/discount offers applicable to the Prizes and winner will not receive the difference between actual and approximate retail value. Prize winners are solely responsible for all applicable taxes and fees associate with Prize receipt and use. U.S. winners may be issued an IRS 1099 form for Prizes with an ARV over \$600. No more than the stated number of Prizes will be awarded.

**6. WINNER NOTIFICATION & ACCEPTANCE:** Sponsor will attempt to notify the Potential Prize winner by email, mail, or phone, at Sponsor's sole election, within approximately five (5) days of drawing using the information provided with the Entry. Sponsor is not responsible for any change in information or typographical errors submitted by entrant. Each potential winner must respond using the provided contact information and instructions within seventy-two (72) hours of notification. Potential winners are subject to verification, including verification of age and eligibility. If a potential winner fails or refuses to provide the information requested by the date stated in the notification message or any other request from Sponsor related to the prize award, the potential winner may be disqualified. The Potential Prize winner will be required to sign and return an Affidavit/Declaration of Eligibility/Release of Liability form, a publicity release, and/or provide personal information to enable Sponsor to fulfill its tax reporting obligations within the time periods specified in the Prize notification message to claim their Prize.
