Turn the table top upside down on a soft surface to prevent scratches. Insert one table leg into the table tops leg socket.

Install the allen screws to secure the legs, tightening with the allen wrench.

After securing three table legs, position the bottom shelf 6 inches or more above the ground.

Slide the last table leg into place and secure with the allen screw.

Each corner support requires two allen screws. Wait until the table is completely assembled before securely tightening each allen screw.

All four table legs can be adjusted for surfaces that are not completely level. To do this, rotate the plastic foot cap for differences in floor surfaces.

It is recommended that two people rotate the table onto its feet once the legs have been secured.
