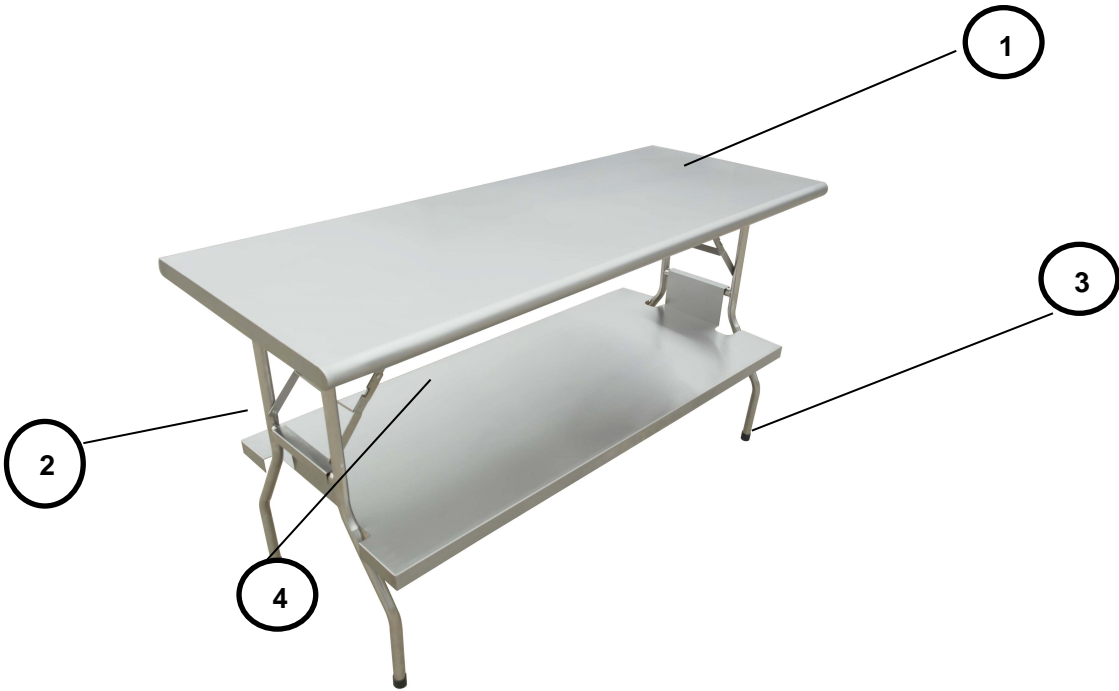

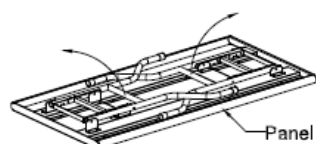

Do not exceed the weight limits stated for each table: 48" 350 pounds (160 kg); shelf 88 pounds (40 kg).

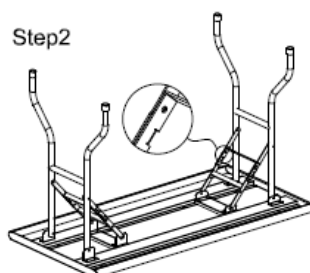

If the product does not comply with this limited warranty, Your sole and exclusive remedy is that We will, at our sole option and within a commercially reasonable time, either replace the product or product component without charge to You or refund the purchase price (less shipping). This limited warranty is not transferable.

### Limitations on the Warranty
