

Assembly


Step 1

Align the wall brackets (B) on the bottom of the shelf (A).




Step 2

Using the screw sets (C), attached the wall brackets (B) to the bottom of the shelf (A). Put each screw in so the washer and nut will be visible when looking at the bottom of the shelf. Place a washer before placing the nut on each screw. Loosely place nuts on each screw until all screws are placed; then tighten.



Step 3

The shelf is ready to place on the wall. Make sure the wall is able to hold the weight of a fully loaded shelf.
