# Sportsman's Guide Buyer's Club® Terms & Conditions

The Sportsman's Guide, Inc. ("Sportsman's Guide," "we," "our" or "us") offers its customers the opportunity to participate in the Sportsman's Guide Buyer's Club (the "Buyer's Club" or "Program"). The terms and conditions below apply to the Program and are between you ("you" or "Member") and Sportsman's Guide. If you sign up for the Buyer's Club you accept these terms, conditions, limitations, and requirements, as well as the other terms, conditions, limitations, and requirements available on the sportmansguide.com website, as each may be changed over time with or without notice to you (the "Terms").

# **Membership Term and Benefits**

The Buyer's Club is a subscription-based program offered exclusively for Sportsman's Guide® customers. A one-year Membership is available for an annual fee (currently USD \$59.99) (the "Membership") and may be purchased online at sportsmansguide.com or when you place a phone or catalog order. The Membership term is one (1) year and may be renewed pursuant to the Terms. The initial term combined with the renewal term constitutes the "Membership Term."

During the Membership Term, Members receive:

- Special Buyer's Club pricing on products purchased through Sportsman's Guide, including 10% off non-member pricing on clothing, boots, shoes, gear and other merchandise and 5% off night vision, trolling motors, electronics, generators, guns, and ammunition;
- Free standard shipping on orders of \$49 or more; ☐ Monthly and quarterly giveaways; ☐ Member's only offers and promotions; and
- Installment payment option with Buyer's Club 4-Pay powered by Sezzle.

Your Membership benefits start as soon as you sign-up and pay the Membership fee. Please keep reading to learn more about the Program's exclusive benefits.

<u>Pricing</u>: Program pricing and discounts apply to an extensive selection of our offered merchandise; however some exclusions do apply, for example, Program discount pricing does not apply to certain products subject to a manufacturer's pricing program. In addition, we may exclude products from the Program at our sole discretion. Certain purchases may be subject to special order or handling fees and taxes which are not subject to the Program's discount. Look for the listed Buyer's Club price to know the product's price.

<u>Free Shipping</u>: Member will receive free standard shipping on every order with \$49 or more in merchandise. Free shipping only applies to standard shipping fees to U.S. destinations, all other fees (heavy bulky, gun processing, Alaska/Hawaii, and express shipping) still apply. Does not apply to Canadian or International orders.

<u>Promotions</u>: Periodically Members will receive limited-time offers via email or mail. Members are encouraged to keep their email address current to ensure they receive the most out of this benefit.

Buyer's Club 4-Pay powered by Sezzle: Buyer's Club 4-Pay provides Members the flexibility to pay for online merchandise orders of \$150 or more in 4 interest-free installments by using Sezzle as the method of payment. The first installment, which will include 25% (1/4) of the order total after any promotions, gift cards or discounts, will be billed at the time of purchase. The three remaining installments will automatically be billed over the next three months to the credit/debit card used for your purchase, or another credit/debit card that Sezzle may have on file for your account. Buyer's Club 4- Pay is available only for online merchandise orders of \$150 or more placed at SportsmansGuide.com using Sezzle as method of payment, and cannot be used on catalog mail orders, phone orders, or purchases made in the Sportsman's Guide retail store. 4-Pay cannot be used when all items in an order are on backorder. However, 4-Pay can be used if at least one of the items in the order is in stock at the time of purchase. 4-pay can be used to purchase gift card(s); however, the purchase amount of the gift card(s) does not count toward the \$150 minimum. 4-Pay can be used on orders for which a gift card(s) is used for partial payment; however, the partial payment amount made via gift card(s) does not count toward the \$150 minimum. The 4-Pay option must be selected when placing an order; it cannot be applied after an order is confirmed. Customer eligibility for 4-Pay is at the sole discretion of Sezzle and is subject to credit approval. Other limitations may apply.

### **Membership Cancellation**

Members may cancel their Membership at any time during their Membership term. If the Member cancels their membership within 90 days of their active Membership start date, they will receive a full refund, less any benefits/savings received in their current Membership term (for example, Buyer's Club Discounts received or free shipping). Refunds will not be made for any Club Memberships canceled after 90 days, even if the Member did not use any of the benefits during the Membership term. #### Membership Renewal

Auto-Renew Members: Members receive a renewal notice approximately thirty (30) days prior their Membership renewal billing date which includes the Membership expiration date and any applicable renewal instructions. If we have a valid email address on file, the Member receives this notice by email, otherwise notices are mailed to the account holder's primary address. Members may choose to opt out of the auto-renew feature for their Membership. UNLESS YOU NOTIFY US BEFORE YOUR MEMBERSHIP EXPIRATION DATE THAT YOU DO NOT WANT TO PARTICIPATE IN AUTO-RENEW OR WISH TO CANCEL YOUR MEMBERSHIP ENTIRELY, YOU UNDERSTAND THAT YOUR BUYER'S CLUB MEMBERSHIP WILL AUTOMATICALLY CONTINUE FOR ANOTHER TWELVE (12) MONTHS AND YOU AUTHORIZE US TO CHARGE AND COLLECT THE THEN-CURRENT MEMBERSHIP FEES (AND ANY APPLICABLE TAXES) USING ANY CARD WE HAVE ON FILE FOR YOU. WE MAY DO THIS WITHOUT ANY ADDITIONAL NOTICE TO YOU, UNLESS REQUIRED BY LAW.

<u>Non Auto-Renew Members</u>: For Members that have opted out of the auto-renew feature, their Membership will automatically expire 1 year from the original purchase date. To avoid a lapse in benefits, Members should renew through their Account Dashboard or the Sportsman's Guide Customer Service Department prior to the expiration date.

Sportsman's Guide is not responsible for late fees, over limit fees, finance charges or other charges imposed by third-party credit card issuers as a result of Membership Term renewal. The renewal notice and the customer's ability to cancel are considered sufficient notification of the auto-renew charge.
